YIL is one of the major shareholders of JKCL (rated 'CARE A+' and 'PR1+') with 31.37% of the total paid up capital in the company (as on March 31, 2009). For FY09, YIL achieved total income of Rs.11.3 crore with PAT of Rs.10.5 crore. For H1FY10 (unaudited), the company achieved total income of Rs.8 crore with PAT of Rs.7 crore.
